

## MARKET REVIEW

- April 2011 WPI fell to 8.66% from the revised WPI of 9.04% for March 2011.
- Concerns over fiscal consolidation amidst continuous issuance of sovereign bonds led to yields hardening across the curve.
- Fourth quarter GDP for FY 2010-11 eased to 7.80%, as compared to 8.30% in the previous quarter - lower than expectations.

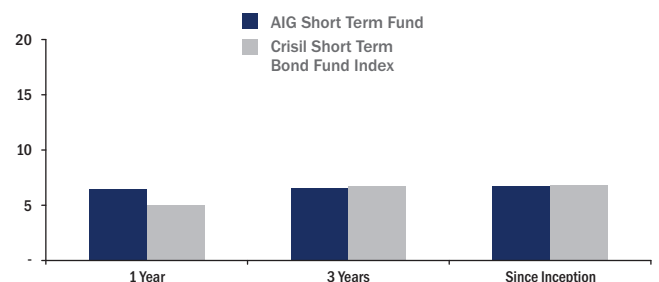

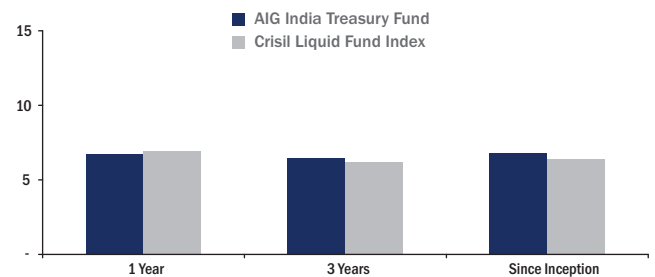

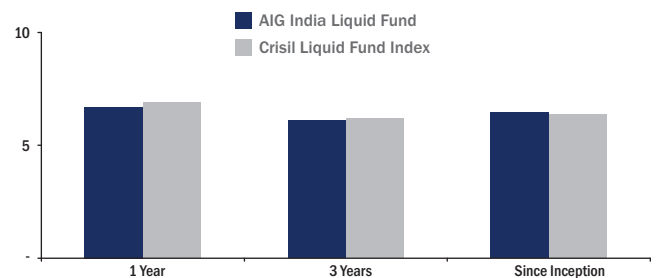
