INSTRUCTIONS FOR NOMINATION

1. The Investor has an option to appoint maximum upto 3 nominees (as prescribed under the SEBI Regulations).
2. The percentage of allocation/share in favour of each of the nominees should be indicated against their name and such allocation/share should be in whole numbers without any decimals making a total of 100 percent.
3. In the event of the Unitholders not indicating the percentage of allocation/share for each of the nominees, AIG Global Asset Management Company (India) Private Ltd (AMC) shall settle the claim equally amongst all the nominees.
4. The nomination can be made only by individuals applying for holding units on their own behalf singly or jointly. Non-individuals including society, trust, body corporate, partnership firm, Karta of Hindu Undivided Family, holder of Power of Attorney cannot nominate.
5. Nomination in respect of the units stands rescinded upon the transfer of units.
6. Separate nomination form should be filled for each folio.
7. Nomination shall be registered only if the form is filled completely and is signed by all joint holders if the units are held jointly.
8. In case the mode of holding is single and the single holder has made the nomination in favor of a single nominee, then 100% of the investment of the mentioned folio number shall be assumed to be allocated to that nominee in the event of death of the sole investor. This is however on due compliance with the necessary documentation by the nominee as prescribed by the AMC.
9. If no guardian is provided, nomination of the minor will be invalid. Guardian should be a person other than the unitholder(s).
10. The cancellation of nomination can be made only by those individuals who hold units in their own name, either solely or jointly and who have originally made the nomination.
11. On cancellation of the nomination, the nomination shall stand rescinded and the AMC shall not be under any obligation to transfer the units in favour of the Nominee.
