- Re-registration form should be submitted at least 15 days prior to the next SIP date.
- If the Re-registration request submission is less than 15 days prior to the next SIP/STP date, SIP/STP for load applicability will be effective from the subsequent SIP/STP date.
- Exit load will be applicable as per the scheme load structure as stated in the Scheme Information Document.
- This form is to be used *only* for entry load waiver for future existing SIPs/STPs and *not* for renewal of the SIP/STP that has ended.
- Only one folio per form is accepted.

*SEBI CIRCULAR : In accordance with the requirements specified by the SEBI circular no. SEBI/IMD/CIR No.4/168230/09 dated June 30, 2009, no entry load will be charged for purchase / additional purchase / switch-in accepted by the Fund with effect from August 1, 2009. Similarly, no entry load will be charged with respect to applications for registrations under systematic investment plans / systematic transfer plans accepted by the Fund with effect from August 1, 2009.
